16 Motions Tabled for Debate

16.1That the value "sixty five per cent" replaces the value "seventy five per cent" in Article 17.1.2 of the National Constitution for the duration of the conference

16.2 This Conference adopts the new

- National Standing Orders
- Model Area Constitution
- Group Constitution

as per the attached documentation with effect from the close of business of this conference

Notes to groups related motion 14.2

When accepted, the following changes will apply as at the close of business of this Conference.

- The current National Constitution will be replaced in its entirety by this new National Constitution.
- The current National Standing Orders will be replaced in its entirety by this new National Standing Orders
- Any current Area Standing Orders will remain active unless they are in conflict with these new documents. Where conflict exists, this must be addressed at the next Area Meeting.
- Any current Group Standing Orders will remain active unless they
 are in conflict with these new documents. Where conflict exists this
 must be addressed at the next Group AGM
- All current Area Constitutions will be replaced by this new Area Constitution as per clause 5.8 of the current National Constitution
- All current Group Constitutions will be replaced by this new Group Constitution as per clause 3.3c of the National Constitution
- All current documentation is identified as "Adopted at the 1992 Annual National Conference 29 March 1992, Minehead, Somerset and as revised at subsequent ANC'S.

17 Group Motions

17.1

That the name of the Federation be changed by removing the word "Eighteen" from the title. This name change is to be adopted from the 1st May 2006 and shall amend all relevant entries in the National Constitution and standing orders; Area Constitution and standing orders; Group Constitutions and standing orders; Second-Tier Group Constitution and standing orders.

The Federation is on the brink of major change to fall in line with the Area Lead Option that was voted on at the last ANC in 2005. With the closure of the office as part of the adopted motion, all branded stationery and publicity material will need to be amended to reflect the new Flextel number and address when this is known. As a result, this is the perfect opportunity to change the name without incurring extra costs and remove the federation from inaccurate association with the adult industry and the damage this does to the reputation of the Federation. The "Eighteen" in the title is misleading and often discourages potential new members and portrays the wrong image. The proposal is that the "Eighteen" is dropped from the name across the board. The intention of this motion is not to change the constitutions in any other way so groups such as "So'ton Friends" could still retain their group name, but "Southern Area Eighteen Plus" would become "Southern Area Plus"

17.2

That the National constitution be amended to allow for the provision to extend the participation at the Annual General Meeting to the groups by inserting the following wording into the National Constitution.

- 7.12 PROVISION TO EXTEND PARTICIPATION AT THE ANNUAL GENERAL MEETING TO THE GROUPS
- 7.12.1 The NEC may by a majority resolution, invite individuals who are members of groups of the Member Areas (hereinafter: "Group Delegates") to attend the AGM of the Federation, PROVIDED THAT:
- 7.12.1.1 Every such group is so invited;
- 7.12.1.2 There shall be no more than two Group Delegates from one such group;
- 7.12.1.3 Group Delegates will be entitled to vote on the business of the NEC, in which case, the Area Representatives shall be required to vote in such a way as to reflect the votes of Group Delegates.
- 7.12.1.4 In all votes mentioned under 7.12.1.3,
- 7.12.1.4.1 Where the matter affects this constitution, the Area Representatives shall only vote in favour of a motion which is passed with a 75% majority of the Group Delegates;
- 7.12.1.4.2 For all other matters, the Area Representatives shall vote as indicated by the majority of the Group Delegates.
- 7.12.2 Where a resolution under 7.12.1 is so passed, business of the November Ordinary Meeting of the NEC shall not be required to be considered by Member Areas at their Conferences immediately preceding the AGM.

This motion is purely intended to allow flexibility in the new constitution by giving the Federation the ability to extend the participation at the Annual General Meeting to the Groups should there the will or the requirement to do so in the future. This motion in itself does not automatically mean groups will be invited to provide delegates. But merely gives the Federation the ability to extend the participation in the future should that be the will by majority resolution.

17.3 To extend the participation at the next Annual General Meeting to the groups in line with the provision outlined in newly created 7.12 of the new national constitution.

This motion is intended to allow groups to send up to two delegates to the next Annual General Meeting. The intention would be to hold the Annual General Meeting at an accessible location that is cost-effective i.e. not requiring any additional levies to the Area's or Groups, but allowing the important input and networking from the groups. The intention would be to hold this over one day negating the need for the current trappings of a hotel and dinner dance that has made the current Annual National Conference so costly.
